Colleen Medeiros provided an overview of the current CCJTC officers, Jay Norton (Chair-Town of Wellfleet) and Griffin Ryder (Vice Chair – Town of Brewster) who term is from July 1, 2022 through June 30, 2023. Ms. Medeiros shared that nominations for the Chair and Vice Chair are performed annually and the nominated positions for the next term would start July 1, 2023, and end June 30, 2024.

Thomas Andrade nominated Griffin Ryder as Chair and asked if any new JTC members may be interested in the role of Vice Chair.

Jay Norton asked if Griffin Ryder had any opposition to becoming Chair. Mr. Ryder accepted Mr. Andrade's nomination.

Mr. Norton nominated himself as Vice Chair. No objections were made to either nomination.

Federal Fiscal Year (October 1 – September 30) 2024 Unified Planning Work **Program ("UPWP") Development:** Staff will review the draft 2024 UPWP which summarizes all significant transportation activities planned for the year on Cape Cod. Committee members may ask questions and vote to make a recommendation to the Cape Cod Metropolitan Planning Organization to release the draft 2024 UPWP for a 21-day public comment period.

David Nolan delivered a presentation on the FFY 2024 Unified Planning Work Program. Mr. Nolan reviewed the UPWP process and timeline and described the types of transportation work undertaken by Commission staff each year. Mr. Nolan reviewed the transportation tasks and highlighted the following specific tasks:

- Task 1.6 Canal Bridges Program Coordination
- Task 2.4 Unpaved Road Inventory
- Task 3.1 Chatham Main Street Parking and Circulation Study
- Task 3.2 Interchange Safety Analysis
- Task 3.3 Sidewalk Connectivity to CCRTA Routes and Multi-Family Housing
- Task 3.4 Guidance for EV Charging Station Needs
- Task 3.5 Regional Safety Action Plan and Speed Limit Change Policy support
- Task 4.1 Transportation Management Associations (TMA) Research
- Task 4.2 CCRTA Fleet Electrification Support

Mr. Nolan concluded his presentation by sharing the draft FFY 2024 funding summary for the tasks discussed.

Sean Polay asked what parameters are being used for multi-family housing (Task 3.3.). Mr. Nolan shared that the parameters are to be determined, but that existing housing layers would be the starting point. All affordable housing and mixed used housing would be included. Steven Tupper shared the Commission is working on a regional housing analysis that is currently underway which includes community housing profiles for all 15 Cape Cod towns. The regional housing analysis will tie into Task 3.3.

Thomas Andrade asked if there was a draft study area of the CCRTA bus stops and housing areas to be looked at for JTC member review. Mr. Nolan shared that when the UPWP begins in October, the Commission can come back to the JTC to review the areas being looked at and for feedback from members. Pamela Haznar shared that bus stop accommodations could potentially be made within a TIP project, such as shelters or benches at CCRTA stops, if a community brings a location to our attention.

A motion to recommend the CCMPO release the draft 2024 UPWP document for a 21-day public comment period as presented was made by Thomas Andrade, second by Sean Polay. Members voted as follows:

Federal Fiscal Years (October 1 – September 30) 2023-2027 Transportation **Improvement Program ("TIP") Amendment 2:** Staff will describe the 2023-2027 TIP Amendment 2, which would increase the funding amounts to match the increased project cost estimates for the Barnstable Bearses Way Shared Use Path project. Committee members may vote to make a recommendation to the Cape Cod Metropolitan Planning Organization to release the 2023-2027 TIP Amendment 2 for a 21-day public comment period.

Colleen Medeiros provided an overview of the draft 2023-2027 TIP Amendment 2. Ms. Medeiros shared that the amendment relates to the FFY 2023 Bearses Way Shared Use Path Project. The total project cost is \$3,221,444 and is currently obligated for \$1,995,386 in FFY 2023 using regional target funding. Amendment two funds the remaining \$1,226,058 in FFY 2023 using regional target funds.

Thomas Andrade and Jay Norton asked where the extra funding was being sourced from. Raissah Kouame shared that it would be funded using regional target funds and CMAQ funds.

Griffin Ryder departed the meeting at 9:04AM.

Federal Fiscal Years (October 1 – September 30) 2024-2028 Transportation Improvement Program ("TIP") Development: Staff will review the draft 2024-2028 TIP, which summarizes the regionally significant transportation infrastructure projects receiving federal funding for construction over the next five years. Committee members may ask staff questions and vote to make a recommendation to the Cape Cod Metropolitan Planning Organization to release the draft 2024-2028 TIP for a 21day public comment period.

Colleen Medeiros provided an overview of the TIP development process, schedule and project categories. The TIP is a five-year planning schedule of regional construction projects, which include roadway, transit, and multimodal projects.

Ms. Medeiros provided a brief overview of the regional target funds including provided the draft FFY 2024-2028 list of transit projects for the CCRTA. Ms. Medeiros shared that the CCRTA received an increase in funding and is currently working on electrification of their vehicle fleet.

Ms. Medeiros briefly reviewed project selection factors and a list of eligible TIP projects based on readiness.

Ms. Medeiros provided an overview of the draft FFY 2024-2028 TIP scenario for the regionally prioritized projects that was recommended to the CCMPO in March in which the CCMPO agreed with the CCJTC recommendation. Ms. Medeiros shared the draft FFY 2024-2028 State Prioritized Projects.

Ms. Medeiros provided an overview of the the proposed distribution of TIP funds by community. The overall the goal is that each town has been funded previously or is going to be funded. Ms. Medeiros highlighted that the majority of the Cape's 15 towns will be receiving TIP funds in the next five years or has previously received TIP funds in the last ten years with the exception for the Town of Eastham, which has not been funded through the TIP in the past ten years. Commission staff are coordinating with the Town and MassDOT to resolve this and MassDOT has recently initiated a project in Eastham at the Orleans/Eastham rotary, which is now a TIP eligible project.

Ms. Medeiros also shared a Project Equity Analysis (positive impact anticipated on impacted population). The analysis shows that nearly every TIP project will have a positive effect to a low income, minority, or limited English speaking population. Ms. Medeiros also shared the TIP Greenhouse Gas (GHG) Analysis which includes projects that will reduce congestion and provide multi-modal accommodations for a positive reduction in GHG in the region.

A motion to recommend the CCMPO release the draft 2024-2028 TIP for a 21-day public comment period was made by Thomas Andrade, second by Jim Vincent. Members voted as follows:

**2024 Cape Cod Regional Transportation Plan ("RTP"):** Staff will provide an update on the development of the 2024 RTP. The RTP is the region's long range transportation vision for the Cape Cod region and includes all modes of transportation.

Ms. Medeiros provided an update for the Cape Cod RTP. The RTP is the region's long range transportation plan (20-25 years), includes all modes of transportation, establishes the regional vision, and prioritizes infrastructure projects within available funding. The RTP was last updated in 2019. Ms. Medeiros briefly reviewed the vision statement, draft goals, and potential future projects/programs.

Ms. Medeiros provided an overview of the Commission's online survey and mapping tool was released immediately following the March JTC meeting. Over 350 submissions have been made to the online survey to date.

Ms. Medeiros shared that the Commission has held a number of recent RTP outreach meetings including one in Truro, a bike advocates meeting during the month of April and virtual listening session which was recorded and is available on the website. Additionally, several targeted RTP outreach meetings are planned to be held with specific organizations and targeted groups. Ms. Medeiros shared that there will be additional RTP public outreach meetings in the month of June.

**Transportation Electrification:** Staff will lead a discussion on local interest, concerns, and opportunities related to electric vehicle infrastructure and fleet electrification.

Steven Tupper provided an update for EV infrastructure and fleet electrification. Mr. Tupper asked members for feedback to determine how the Commission could best assist towns as they transition to electric vehicles for all or part of their fleets.

Jay Norton shared that support with funding opportunities or available grants to help with implementation of the transition to electric vehicles and charging stations would be helpful. Mr. Norton mentioned that sharing information regarding EV technology as it is evolving will also be helpful and thanked the Commission for their support.



Paul Tilton provided a range of feedback for EV support items, such as grants, working with Eversource, pricing structure, the various types of charging stations and construction and maintenance of charging stations,

Thomas Andrade mentioned a pilot program for one EV charging station to be implemented in the Town of Dennis. Mr. Andrade shared that during town meeting conversations the biggest concern was if this would cost the town money. Mr. Andrade shared that the Town of Dennis has an Alternative Energy Commission in Dennis and that they have been working on the EV transition.

Mr. Norton agreed with Mr. Tilton and Mr. Andrade and shared that a clear understanding of the transition would be helpful for towns as they move forward in planning and implementation.

Mr. Tilton shared a grant opportunity that is for any EV charging station within 1-mile of Route 6. Mr. Tilton shared that a map showing where charging stations are would be helpful, and that as a region, towns could come together to apply for this grant opportunity. Mr. Norton asked Mr. Tupper if the Commission has mapping already in place showing where charging stations are in place. Mr. Tupper shared that a mapping tool was created during the development of the Cape Cod Climate Action Plan and that this conversation will help inform an update to the mapping tool for its next version. Mr. Tupper shared federal, state, utility, and other grant opportunities will be available for EV transition.

Mr. Tupper introduced Helaine Goudreau, Special Projects Coordinator, who recently joined the Commission. Ms. Goudreau will be assisting with some of the elements of the EV transition. Mr. Tupper shared that the Commission is willing to bring back the topic of transportation electrification to future meetings to assist towns with questions and to share updates.

MassDOT, Cape Cod Regional Transit Authority, and Cape Cod Commission staff will report on recent and upcoming transportation initiatives across Cape Cod.

MassDOT update:

Barbara Lachance provided the following updates for MassDOT:

- Wellfleet Intersection improvements and related work at Route 6 and Main Street revised review of the 100% design has been completed/PS&E submission expected end of April 2023
- Barnstable Shared used path along Bearses Way from Route 28 to Pitchers Way 100% design review complete/PS&E submission expected mid-May 2023
- Wellfleet Pavement preservation and related work on Route 6 100% design submission expected April 2023
- Bourne Rotary improvements 100% design revision pending/ PS&E submission expected mid-
- Mashpee Corridor improvements Route 151 Phase 2 100% design submission expected April

- Harwich Sidewalk Installation Route 28 Public Hearing held January 2023/75% design submission pending
- Dennis/Yarmouth Bridge replacement Route 28 over Bass River At 75% Design/ 100% design submission pending
- Barnstable/Yarmouth Cape Cod Rail Trail Phase 3 at 75% design/ 100% design expected April
- Barnstable Park and Ride Route 132 DJW received March 2023 and is currently under review
- Dennis/Harwich Construction and related work Route 28 Upper County Road to Herring River Bridge – at 25% design/75% design pending
- Provincetown Corridor improvements and related work on Shank Painter Road DJW approved April 2023/ Design Public Hearing scheduled June 13, 2023
- Bourne Scenic Highway Design Public Hearing scheduled June 8, 2023
- Harwich Safe Routes to School DJW review complete/comment resolution meeting pending
- Bourne Rail Trail Phase 1 Sketch plans have been reviewed for boardwalk/100% design submission expected end of 2023
- Provincetown/Truro Resurfacing and related work on Route 6 MassDOT HQ in process of designating design consultant for project
- Barnstable Resurfacing and related work on Route 6 Concept plans received and currently under review
- Chatham Intersection improvements and related work 25% design submission pending
- Dennis Corridor improvements and streetscape on Main Street from Uncle Barneys Road to Old Main St Phase 2 – concept plans submitted and comments made/project manager response pending/ new schedule needed

Ms. Lachance shared that the Project Review Committee (PRC) will be holding their annual meeting May 24, 2023, and that the Sandwich Shared use Path project will be presented at the meeting.

Thomas Andrade asked Ms. Lachance if the Route 28 bridge over the Bass River project is still on schedule for the end of 2023 or beginning of 2024. Ms. Lachance followed up via email and shared that the 100% design submission is expected May 2023 and that the project schedule is still on track.

#### **CCRTA update**:

Deb Shores provided the update for the CCRTA. Ms. Shores shared that the CCRTA is working on expansion of service in Provincetown for early morning and late-night service for shoulder and peak seasons. Ms. Shores shared that the EV consultant will be visiting for the electrification survey to visit the operations center and administration buildings. The visit will help to determine what infrastructure may be needed and what currently works for the EV transition. Ms. Shores shared that the next EV newsletter would be coming out in the next week.

#### **Cape Cod Commission Update:**



Colleen Medeiros provided the update for the Commission. Ms. Medeiros shared the upcoming summer traffic data collection requests deadline and asked members to email David Nolan by 04/14/2023. The data collection includes ATRs (Volumes, class and/or speed), turning movement counts (weekday AM or PM), Bike Path Counts (location and duration), and speed studies. Data collection efforts will start in June 2023.
