the MHC, he primarily assists the volunteer local commissions around the state in community-wide historic preservation planning. MHC publications prepared by Christopher include Preservation through Bylaws and Ordinances, the Preservation Planning Manual, and A Guidebook for Historic District Commissions. He has assisted several towns in western Massachusetts prepare a community-wide historic property survey plan. He currently resides in western Massachusetts but was a resident of Eastham during college.

**Rebecca Williams** is Program Officer in the Northeast Office of the National Trust for Historic Preservation, staffing Massachusetts, New Hampshire, and Vermont. She has a Masters degree in Historic Preservation from the University of Vermont and has a background in museums. Prior to her time at the National Trust, she was a preservation consultant in Vermont, working on projects ranging from National Register nominations to analyzing the historic paint schemes in a variety of building types. Rebecca has also volunteered at several building conservation field schools in National Park Service sites in California and Texas.

**Sally Zimmerman** (Boston University, MA, Historic Preservation, 1981; Mount Holyoke College, BA cum laude, American History, 1975) is Preservation Specialist at Historic New England, staffing the Historic Homeowner Program. Sally worked for many years as a preservation planner at the Cambridge Historical Commission, where her work focused on neighborhood conservation districts, an innovative alternative to traditional local historic districts. She has also worked at the Massachusetts Historical Commission, as a member of the reconnaissance survey teams, as preservation planner, and as director of the Preservation Planning division. She is author of numerous district study reports and National Register nominations, as well as a guide for homeowners and preservation commissions on historically appropriate exterior paint colors.

## About the Speakers

**Kevin F. Galligan** is energy efficiency manager at the Cape Light Compact, Barnstable County, a municipal aggregator and program administrator of the rate-payer funded energy efficiency programs. He is also adjunct instructor at Cape Cod Community College teaching energy efficiency and conservation as part of a National Science Foundation grant awarded to the college to promote and develop a trained workforce to install renewable energy systems on Cape Cod. Kevin has over twenty-eight years of energy industry experience including engineering project management with Duke Energy (now Spectra Energy) prior to joining the Cape Light Compact. Kevin is a Board Member of the National Energy Education Development Project, and the Commonwealth of Massachusetts Energy Facilities Siting Board and is an ex-officio member of the Commonwealth of Massachusetts Energy Efficiency Advisory Council.

**Jade Mortimer** began restoring windows on Cape Cod in 1996, her first project being the restoration of the Seth Nickerson House, the oldest standing house in Provincetown, built in 1746. Heartwood has restored over 850 windows throughout New England, working with the client to simplify and enhance the capability and beauty of old wood windows so that they may continue to serve for future generations. Heartwood Window Restoration offers complete restoration services of historic wood windows as well as conditions assessment reports in the northeast region. They also offer window restoration/repair workshops for the homeowner, building manager and those considering a career in window preservation. Jade, owner of Heartwood, is a co-moderator at [www.HistoricHomeWorks.com](http://www.HistoricHomeWorks.com), and a founding member of the New England Window Restoration Alliance.

**Christopher Skelly** is the Director of Local Government Programs at the Massachusetts Historical Commission (MHC). He has been at the Commission for over 10 years. His degrees include a Bachelor of Landscape Architecture and a Masters in Regional Planning from the University of Massachusetts at Amherst. At
