About the Speakers (continued)

Sarah Korjeff is a senior planner and historic preservation specialist with the Cape Cod Commission, a regional planning and regulatory agency serving the 15 towns of Barnstable County. Ms. Korjeff is responsible for historic preservation initiatives and architectural design review. She coordinated production of the Commission's design manuals *Designing the Future to Honor the Past* and *Contextual Design on Cape Cod* as well as numerous reports focusing on historic resources and community character. Ms. Korjeff wrote a column on architecture and design for *The Cape Cod Voice* from 2001 to 2007, and regularly gives presentations on Cape Cod Architecture and History. She serves on the boards of the Nauset Light Preservation Society and the Yarmouth New Church Preservation Foundation. She holds a bachelor's degree in History from Middlebury College and a Master's degree in Historic Preservation from the University of Pennsylvania.

Valerie Talmage is an experienced preservation professional and non-profit administrator. She is the former Executive Director of the Massachusetts Historical Commission and MA State Historic Preservation Officer. After 15 years of public administration, her career transitioned to land conservation projects working as a Land Protection Specialist for The Trustees of Reservations. In 1997, Ms. Talmage became the Director of Projects for the New England Office of the Trust for Public Land, overseeing a \$20 - \$50 million portfolio of conservation real estate transactions. In 2007, Ms. Talmage joined Preserve Rhode Island, the statewide preservation organization that stewards five historic sites while leading the state's efforts to encourage Rhode Islanders to protect special places.

About the Speakers

Eric Dray is a preservation planning consultant. His recent work includes: co-writing a series of historic district training videos produced by the Massachusetts Historical Commission (MHC); writing National Register district nominations for Sandwich and Plymouth; creating Preservation Plans for Carver and Wareham; and writing review guidelines for the Falmouth, Plymouth and Lenox Historic District Commissions. Eric has a Masters in Preservation and a Law Degree from Boston University, where he is currently an adjunct professor of preservation planning. He serves as Chair of the Provincetown Historical Commission, and was Chair of Provincetown's Historic District Study Committee and served on the newly created commission.

Wendall Kalsow is the President of McGinley Kalsow & Associates, Inc., (MKA) a leading architecture, historic preservation and planning firm in New England. He is a recognized expert in the assessment, restoration, preservation, and adaptive reuse of historic structures including many distinguished National Register Properties and National Historic Landmarks. Mr. Kalsow has extensive knowledge regarding historic preservation regulations, AAB codes, accessibility solutions and phased restoration of historic buildings. He was recently recognized with the Paul E. Tsongas Profiles in Preservation Award. Mr. Kalsow received his B.S. in Architecture from Iowa State University and a Masters in Architecture from the University of Michigan. He is registered in Massachusetts, New Hampshire and Rhode Island. Some of Mr. Kalsow's award winning projects include: Provincetown Town Hall, Gate of Heaven Church, Emmanuel Church, Bigelow Chapel, Gasson Hall at Boston College, Newburyport Town Hall and the Edmund Fowle House in Watertown. Most recently MKA completed the comprehensive renovation/restoration of the historic town halls in Sandwich and Provincetown. These projects demonstrate an in depth knowledge in the restoration of character defining elements, repair of traditional building materials and creative integration of modern amenities and life-safety features.
