MODIFICATION OF DEVELOPMENT OF REGIONAL IMPACT DECISION

The Cape Cod Commission (Commission) hereby approves a Modification to an approved Development of Regional Impact Decision originally dated October 17, 1996 as modified on June 16, 1997, July 27, 1998, January 3, 2000, February 28, 2000, April 10, 2000, May 8, 2000, July 10, 2000 and **September 18, 2000** pursuant to Section 9(n) of the DRI Enabling Regulations for Cape Cod Hospital.

The application is hereby approved as a Minor Modification #2 under Section 7 of the Administrative Regulations (as revised). The Decision is rendered pursuant to a vote of the Regulatory Committee on **October 16, 2000**.

1) Condition #1 is hereby modified as follows:

The applicant shall amend the Conservation Restriction covering the property identified in the Cape Cod Commission Modification of Development of Regional Impact Hardship Exemption Decision dated October 3, 1996 and modified on June 16, 1997, July 27, 1998, January 3, 2000, February 28, 2000, April 10, 2000, May 8, 2000, July 10, 2000 and **September 18, 2000** to include the activities identified in the Wildlife Habitat Incentive Program (WHIP) administered by the United States Department of Agriculture and provide to the Commission proof of the recording of such Conservation Restriction prior to **November 27, 2000**. In the alternative, the applicant shall deed the property to the Yarmouth Conservation Trust and provide the Cape Cod Commission with proof of the recording of such a deed prior to **November 27, 2000**. Until such deed or Conservation Restriction is recorded, the applicant shall provide a report to the Commission at every Regulatory Committee Meeting. The applicant shall complete Steps 1 and 2 as detailed in a letter from Attorney Patrick M. Butler dated February 25, 2000, prior to **November 27, 2000**.
