MODIFICATION OF DEVELOPMENT OF REGIONAL IMPACT DECISION

**SUMMARY**

Pursuant to Section 13 of the Cape Cod Commission Enabling Regulations (Revised March 2013, with Revised Fee Schedule Effective July 1, 2013), the Limited Development of Regional Impact (DRI) Hardship Exemption decision dated July 7, 2011, as previously amended May 21, 2012, ("Decision") for the above-referenced project is hereby amended as a Minor Modification Type #1 to allow *de minimus* changes to the approved project plans as discussed herein.

All findings and conditions attached to the original decision and subsequent modifications continue to apply except as modified herein.

## **DISCUSSION**

The Applicant recently submitted revised project plans to the Yarmouth site plan review committee, who, through providing comments dated 4/29/14, supported and encouraged the revisions. The plan changes basically propose relocation of the loading/ dock doors for safer and more efficient delivery truck travel in and to the site, which also results in parking lot changes reducing previously approved impervious coverage in the 100 foot wetlands buffer.

## **CONCLUSION**

Based on the foregoing, Condition GC6 of the Decision is hereby modified as a Minor Modification Type #1 by substituting the following plans as the approved project site and building elevation plans, in place of those previously referenced in Condition GC6 of the Decision:

- Site Plan Set for 31 Aaron's Way, W. Yarmouth, consisting of four sheets (Existing Conditions, Landscape & Layout; Grading & Drainage; Details), all sheets with a latest revised date of 4/3/14, prepared by DownCape Engineering, Yarmouth Port, MA for Gladstone, LLC;
- Building Elevation plan sheet (including N, S, E & W Elevations) with a latest revised date of 4/30/14, prepared by DownCape Engineering, Yarmouth Port, MA for Gladstone, LLC.


