Extension Agreement- DRI Public Hearing Period


Re: Development of Regional Impact
Town of Mashpee
Comprehensive Wastewater and Nitrogen Management Plan
(JR20076)

1. The above referenced matter ("Plan") required the preparation of an environmental impact report (EIR) in accordance with the provisions of sections sixty-one to sixty-two H, inclusive, of chapter thirty of the General Laws, and thus is a mandatory Development of Regional Impact pursuant to Section 12(i) of the Cape Cod Commission Act;
2. The Plan underwent joint review between the Cape Cod Commission and the Massachusetts Environmental Policy Act (MEPA) Office during its Final Environmental Impact review (FEIR) comment period;
3. The Development of Regional Impact (DRI) public hearing period was opened, and the first substantive DRI hearing was held by a DRI subcommittee, on the Plan during the FEIR comment period;
4. The Secretary of the Commonwealth's Office of Energy and Environmental Affairs has now certified that the FEIR on the Plan adequately and properly complies with MEPA;
5. A second substantive DRI hearing was held by a DRI subcommittee on November 10, 2015;
5. Pursuant to Section 7(c)(vi) of the Enabling Regulations Governing Developments of Regional Impact: Chapter A of the Code of Cape Cod Commission Regulations (as amended Nov. 2014), the Applicant, Town of Mashpee (Town), and the Cape Cod Commission (Commission) hereby mutually agree to extend the public hearing period on the above referenced matter to May 20, 2016, which extension will allow the Commission, working with the Town, sufficient time to draft a DRI decision aligned and consistent with the Commonwealth's anticipated Watershed Permitting process and the updated area-wide water quality management plan for Barnstable County.




