Provincetown Municipal Airport Capital Improvements Plan Phase 1 #TR06005 December 3, 2015

The Cape Cod Commission will conduct a continued public hearing on **Thursday, December 3, 2015 at 3:00 p.m. in the First District Courthouse, Assembly of Delegates Chambers, 3195 Main Street, Barnstable, MA.** The following project is a mandatory Development of Regional Impact (DRI), and is being reviewed and considered for DRI Hardship Exemption approval. At this hearing the Commission will consider project approval as a DRI Hardship Exemption and adoption of a draft written decision for the project. This notice is being published as required by Section 5 of the Cape Cod Commission Act.

Project Name: Provincetown Municipal Airport Capital Improvements Plan (CIP) Phase 1
Project Applicant: Town of Provincetown through its Airport Commission
Project Site/Location: 176 Race Point Road, Provincetown, MA (Assessors Map/Parcel 1-8-631)
Project Description: Phase 1 of the Provincetown Municipal Airport CIP involves the following project components, designed and proposed to further consistency with operational guidelines issued by the Federal Aviation Administration (FAA), the Massachusetts Department of Transportation (MassDOT) Aeronautics Division, and the Transportation Security Administration (TSA). **The project components are:** to improve westerly taxiway system; relocate east end taxiway; reconstruct terminal apron (footprint pavement reconstruction completed in 2008); reconstruct easterly end of taxiway (footprint pavement reconstruction completed in 2012); install taxiway lighting and construct electric vault; repair sightseeing shack; improve access road to approach light system; construct service access roads to Localizer Equipment Shelter (LES) and to the Automated Weather Observation Station (AWOS); install a perimeter safety/security fence; construct Phase 1 auto parking; and expand turf apron.

Anyone wishing to testify orally will be welcome to do so. Written comments may also be submitted at the hearing, or delivered or mailed to the Cape Cod Commission, P.O. Box 226, 3225 Main Street, Barnstable, MA 02630 for receipt on or before the date of the hearing or until the hearing is closed.
