You are invited to participate in an evaluation of transportation planning process of the Cape Cod Metropolitan Planning Organization (MPO). The Cape Cod MPO provides transportation planning services for the 15 communities on Cape Cod. The planning process in the Cape Cod region is carried out in collaboration with the Massachusetts Department of Transportation, the Cape Cod Commission, the Barnstable County Commissioners, the Wampanoag Tribe, the Cape Cod Regional Transit Authority, and the 15 towns of Cape Cod.

Every four years, the Federal Highway Administration (FHWA) and Federal Transit Administration (FTA) are required by law to review the metropolitan transportation planning process conducted by the Cape Cod MPO and its partners in order to certify that they are carrying out the process in accordance with all applicable Federal requirements.

As part of this review, the FHWA and FTA would like to hear from members of the public regarding their views of how the metropolitan transportation planning process is conducted in the Cape Cod region. The Federal agencies are particularly interested in hearing from people who have participated in the planning process conducted by the Cape Cod MPO.

This public meeting will be conducted by the FHWA and FTA.
