# **Executive Directors Report**

#### COVID-19

The Chair thanked Ms. Senatori for her updates and read the agenda item as printed.

**2019 Comprehensive Economic Development Strategy (CEDS) Year 2 Annual Report:** Cape Cod Commission staff will review the 2019 CEDS Year 2 Annual Report for approval by the Cape Cod Commission. The Commission may vote whether to approve and submit the annual report to the U.S. Economic Development Administration.

Using a Power Point presentation, Jennifer Clinton gave a brief overview of the 2019 Comprehensive Economic Development Strategy (CEDS) Year 2 Annual Report. She stated that the CEDS Performance Measures include the three categories of datapoints 1. People, Residents, Workforce & Income and Vulnerable Populations; 2. The Economy; Employment, Industries, Seasonality and Small Businesses; and 3. Places; Housing, Transportation and Community Character. She reviewed the summary of accomplishments which included Administration and General Planning, Outreach and Information Sharing, Targeted Technical Assistance to Towns and Regional Projects and Initiatives. She then reviewed the year 3 Implementation Plan which includes two new categories: Survey of New Homeowners and Second Homeowners on Cape Cod and Land Use Planning for Economic Resiliency.

Dr. Andrews stated that Provincetown is concerned about the supply of summer housing for workers due to the real estate market and the lack of summer workers. She asked if there was a section in the plan that deals with these issues? Ms. Clinton stated that the housing concerns on Cape Cod include the increase on median sales prices and constrained inventory. We are hoping to get some answers from the surveys that will be conducted over the next few months. That will help to take a look at the rental landscape as we don't have a great data set on available year-round rentals which may be revealed through the 2020 census data as it becomes available. In terms of

the workhouse supply, that is currently a national issue. We don't have the J1 and H2B opportunities that we did before. People are citing that in addition to covid concerns, there are childcare concerns which increased unemployment and contributed to the lack of workforce. This information will come from the workforce and retention program, and we are looking to do more research on what those issues are. Some are identified in the business surveys that have been conducted and the results are available on datacapecod.com. Provincetown had the most data available. She also suggested to check the workforce and housing section of the Annual CEDS Report for what has been identified in the document.

The Chair thanked Ms. Clinton for her presentation.
