INTRODUCTION

The above referenced project, Hydroid, Inc., was approved, with conditions, as a Development of Regional Impact (DRI) Project of Community Benefit (POCB) Hardship Exemption, by a vote of the Cape Cod Commission (Commission) on December 15, 2011.

On September 18, 2012, Hydroid, Inc. (the Applicant) submitted a request for a modification to the Hydroid decision noting that General Condition 10 of the decision requires the Applicant to provide written proof to the Commission that a copy of the decision has been provided to the general contractor(s) at least thirty days prior to commencement of construction. According to the Applicant, a general contractor has not been hired to-date. The Applicant did submit an unsigned Decision Affidavity in its request for its Preliminary Certificate of Compliance in partial compliance with GC10. As all other conditions of the decision have been met for the issuance of a Preliminary Certificate of Compliance, the proposed modification request will allow for the Applicant to obtain a building permit. With the proposed modification, the Applicant will still be required to provide written proof to the Commission that a copy of the decision was provided to the general contractor(s), but this proof will now have to be provided within seven (7) days of the general contractor(s) being engaged.
