#### INTRODUCTION

The above referenced project, Falmouth Ice Arena, was approved, with conditions, as a Limited DRI Hardship Exemption, by a vote of the Cape Cod Commission (Commission) on January 6, 2011 and amended May 26, 2011 by a Minor Modification Type 2 and July 26, 2011, September 15, 2011 and November 4, 2011 by Minor Modification Type 1.

Condition GC7 of the Commission's Limited DRI Hardship Exemption decision ("the decision") requires that Falmouth Youth Hockey League, Inc., prior to the issuance of a Certificate of Use/Occupancy, the Applicant shall obtain a Final Certificate of Compliance from the Commission that states that all conditions in this decision pertaining to issuance of a Final Certificate of Compliance / Certificate of Use/Occupancy have been met. Such Certificate of Compliance shall not be issued unless all conditions connected to the Final Certificate of Compliance have been complied with.

Laura Moynihan, Attorney for Falmouth Youth Hockey League, Inc., contacted Kristy Senatori, Chief Regulatory Officer for the Commission, on December 23, 2011, and provided notification of changes to the approved site plans along with the revised plans. Attorney Moynihan noted that the proposed changes related only to the location of the solar panels within the parking lot of the new Ice Arena.

# DETERMINATION

The Executive Director of the Commission has determined that the request constitutes a *de minimus* change according to Section 13(c)(i) of the Commission's *Enabling Regulations* (Revised March 2011) and is approved as a Type 1 Minor Modification. The following changes shall be made to Finding GF11 and Condition GC5 of the 2011 original Limited DRI Hardship Exemption decision, as modified by a Type II Minor Modification on May 26, 2011 and a Type I Minor Modifications on July 26, 2011, September 15, 2011 and November 4, 2011 by Minor Modification Type 1.
