MISSION AND PURPOSES

MISSION STATEMENT:

"The Cape Cod Commission is the regional land use planning and regulatory agency created in 1990 to serve the citizens and the 15 towns of Barnstable County. Its mission is to manage growth, to protect Cape Cod's unique environment and character, and to foster a healthy community for present and future generations."

PURPOSES:

The Cape Cod Commission provides regional services and coordinates many projects and activities that affect all of Barnstable County. The Commission also provides technical assistance to each Cape town. Activities involve promotion of affordable housing and economic development; protection of coastal, water, and natural resources; preparation of maps and analysis of geographic data; preservation of historic resources; preparation of transportation plans and analysis of traffic congestion and safety issues; and more.

The Cape Cod Commission is charged with reviewing and regulating Developments of Regional Impact, recommending designation of Districts of Critical Planning Concern, and preparing and overseeing the implementation of the Regional Policy Plan, the set of planning policies and objectives that guide development on Cape Cod.










Regional Activities



The Cape Cod Commission's new executive director, Paul Niedzwiecki, joined the agency in September 2007. Throughout the year he met with selectmen and other town boards and civic organizations across Cape Cod to discuss activities related to the recommendations of the "21st Century Task Force on the Cape Cod Commission," revisions to the Regional Policy Plan, development of a Regional Land Use Vision Map, and reorganization of the Commission's staff for Fiscal Year 2009. The restructuring is intended to better reflect the Commission's primary activities: planning, technical services, and regulation.

Implementation of Task Force Recommendations

The agency continued to pursue implementation of the recommendations of the Task Force throughout the year. Activities focused on working with towns to develop the Regional Land Use Vision Map, changing the Regional Policy Plan, introducing more flexible Development of Regional Impact (DRI) thresholds (part of the Commission's Enabling Regulations), and establishing a "Limited DRI Review" process (also part of the Enabling Regulations).

Regional Land Use Vision Map

The Commission's staff worked with municipal staff and officials in Cape towns to develop each town's portion of the proposed Regional Land Use Vision Map, which, among other uses, will help define the regional regulatory thresholds and development review standards. The Regional Land Use Vision Map is being developed using information about sensitive resources, local planning knowledge, and existing patterns of development to identify discrete areas to focus growth and redevelopment efforts, and to identify resource



protection areas that require additional planning or where significant change may not be appropriate. The goal, through identifying appropriate growth areas, planning and implementing necessary infrastructure improvements, and making appropriate regulatory changes, is to create incentives that direct growth and reinvestment to areas where it can be accommodated, and away from areas that require increased protections for ecological, historical, or other reasons.

Up to five broad land use categories have been identified for the Regional Land Use Vision Map: Economic Centers, Villages, Industrial/Service Trade Areas, Resource Protection Areas, and Other areas. Upon completion of a public forum and endorsement of the town's draft map by the town planning board, the town's draft map will be incorporated into a Regional Land Use Vision Map. Once the map is adopted, DRIs will be eligible for minimum performance standards pertaining to Economic Centers to create some initial incentives for investment in these areas.

DRI Thresholds

The Commission is also proposing a flexible framework for DRI thresholds that will allow towns, at their initiative, to customize regional thresholds to address local planning goals for these mapped areas. Towns seeking changes to DRI thresholds will be required to have a design and infrastructure plan adopted by town meeting to address anticipated growth in Economic Centers and Industrial/Service Trade Areas, and may adopt a local impact fee system to provide infrastructure funding. In addition, the Commission may require lower DRI thresholds for Resource Protection Areas as part of the town's request for higher thresholds in some mapped areas. The Commission will hold a public hearing on any proposed DRI threshold changes. Upon approval by the Commission, the revised DRI thresholds for the town will be activated on the Regional Land Use Vision Map.









Regional Policy Plan

The Cape Cod Commission's Planning Committee and staff continued to update the Cape Cod Regional Policy Plan, refining and reorganizing the plan and incorporating proposed new initiatives prompted by the 2006–2007 review of the Cape Cod Commission by the 21st Century Task Force.

The proposed 2008 Regional Policy Plan carries forward the most effective standards, practices, and actions from the existing 2002 version. In some cases, technical clarifications make the standards more specific and readable. In addition, major changes are proposed for the plan's organization, focus, goals, standards, and presentation.

The new Regional Land Use Vision Map (see previous text) is the basis for all regional planning and regulation in the proposed 2008 plan. The plan has also been restructured for a greater emphasis on regional planning; the Regional Regulation section follows the Regional Planning section. The Regional Planning section focuses the Commission's work plan on actions intended to be both measurable and achievable in the next five years. The Regional Regulation section includes measures that make the Development of Regional Impact (DRI) requirements more predictable through the application of the Regional Land Use Vision Map, new options for cash mitigation, and revised or new "Best Development Practices" that the Cape Cod Commission may use in its DRI benefits/detriments analyses.

The Commission voted to release a draft of the proposed plan for public comment on May 29, 2008.





Other Regional Activities

Highlights of other Cape-wide activities during Fiscal Year 2008 include:

Affordable Housing

• The Commission staff developed a regional affordable housing "best practices" toolkit (guidebook) and held a workshop in June 2008 for more than 80 participants.

Economic Development

- The Commission staff coordinated the state-funded Local Technical Assistance/Expedited Permitting Program on Cape Cod. The state provided funds to regional planning agencies for technical assistance to towns for expedited permitting and related support services, as requested. The Commission's work helped the towns of Barnstable, Bourne, Eastham, Falmouth, Sandwich, and Truro (see a summary of the work in each town, under "Technical Services to Towns" later in the report).
- The Commission staff initiated the first phase of the Comprehensive Economic Development Strategy Five-year Update for the region. The first phase includes development of a virtual data center, a set of benchmarks for a balanced economy, a series of briefs about economic "myths and facts," and a narrative summary of the Cape's current economic and demographic conditions. Future phases will involve planning workshops and forums to identify and adopt economic development goals and priorities for the next five years.

Geographic Information System

• The Commission staff provided extensive 3D geographic and topographic analysis for OpenCape Corporation's efforts to design a network of radio transmitters to allow high-capacity broadband Internet service across Cape Cod

Planning and Community Development

• The Commission staff worked with Yarmouth's municipal staff and boards on the town's proposal for a Growth Incentive Zone (GIZ) along a 5.2-mile corridor on Route 28. The Commission board approved the GIZ designation that set the framework for changes in regional DRI thresholds to allow hotel/motel properties within the zone to be renovated or converted to residential units or mixed-use developments with less regulatory involvement by the Commission. Yarmouth's zone is only







the second GIZ on Cape Cod; the first, the Downtown Hyannis Growth Incentive Zone has been in place since April 2006 and is having a significant positive effect related to development goals for that area.

Pre-disaster Mitigation of Natural Hazards

• The Commission staff continued to pursue pre-disaster mitigation (PDM) planning and participate on the Barnstable County Regional Emergency Planning Committee. In September 2007, the staff developed a grant application to the Massachusetts Emergency Management Agency (MEMA) for technical assistance to towns. The staff also worked with partners on a grant-funded project entitled "Effectively Managing Coastal Floodplain Development: Use of Case Studies on Cape Cod, Massachusetts, to Develop a National Model Floodplain Bylaw."

Recreation and Open Space

• The Commission staff coordinated the Cape Cod Pathways program, including organizing a fall Walking Weekend and a spring Cape Walk, to promote the development of an interconnected walking trail system Cape-wide.

Transportation and Energy

• The Commission staff participated in the Renewable Fuels Partnership for the use of renewable fuels for transportation and heating, and, working with the Barnstable County procurement officer, developed a grant proposal to the US Environmental Protection Agency to subsidize biodiesel purchased through county procurement.

Waste Management

• The Commission staff coordinated all Cape towns to review and plan for renewal or alternatives to contracts with the SEMASS waste-to-energy facility for the long-term disposal of municipal solid waste. Activities included organizing outreach to all towns, developing a work outline, forming a regional contract committee, and preparing and presenting a comprehensive analysis in December 2007.

Water Resources

 The Commission staff coordinated water education festivals and educational events related to groundwater in area elementary schools.



Technical Services to Towns

BARNSTABLE

Affordable Housing

- Awarded \$5,000 in Technical Assistance Program funds to the Town of Barnstable for engineering and legal work on a variety of town-owned parcels.
- Committed an additional \$100,000 in HOME funds to Housing Assistance Corporation's Route 132/YMCA 28-unit affordable rental housing development.
- Provided more than \$28,000 in HOME down-payment funds to three households.
- Provided two Soft Second Loan Program mortgages to first-time homebuyers.

Planning and Community Development

- Supported the town's nomination of the Craigville Beach/Centerville Village District of Critical Planning Concern (DCPC). The Barnstable County Assembly of Delegates designated the district on May 21, 2008.
- Submitted a comment letter to the Massachusetts Environmental Policy Act (MEPA) office for the proposed Sandy Neck Beach Facility Expansion.
- Provided \$267,221 in Development of Regional Impact (DRI) mitigation funds toward the purchase of open space.
- Assisted the town in meeting the conditions of the Growth Incentive Zone agreement.
- Began preparatory work on Barnstable's portion of the proposed Regional Land Use Vision Map, which, among other uses, will help define the Commission's regulatory thresholds and development review standards. Next steps will involve discussions and revisions with town staff and officials, followed by a public forum.

- Performed vehicle counts, data analysis, and Geographic Information System (GIS) mapping assistance for businesses in downtown Hyannis (within the gateway to the Growth Incentive Zone), as part of the state-funded Local Technical Assistance/Expedited Permitting Program.
- Worked with MassHighway and the Cape Cod Regional Transit Authority to develop solutions to overcrowding at the Route 132 Park and Ride lot.
- Assisted a road safety audit of Route 28 from Old Stage Road to Phinney's Lane.
- Participated in the Barnstable Transit Development Plan.
- Provided support for MassHighway's "Hyannis Access Study," including staffing the task force subcommittees for roadways, transit, and bicycle/pedestrian issues.

- Began work on an update to the 1995 Route 6A Scenic Byways "Corridor Management Plan." Work by year end included the identification of data and analysis needs and the creation of an online questionnaire to enhance public participation.

Also provided technical comments to the Massachusetts Environmental Policy Act (MEPA) Office on the Draft Environmental Impact Report/Notice of Project Change (October 2006) and on the Final Environmental Impact Report (March 2007) for the Barnstable Wastewater Facilities Plan project.
- Participated in the town briefing on the Massachusetts Estuaries Project (MEP) technical report for Three Bays. Assisted with the state Department of Environmental Protection pilot implementation project for the Three Bays estuary, and developed scenario runs with the Massachusetts Estuaries Project (MEP) technical team.
- Supported the Massachusetts Estuaries Project (MEP) pilot implementation program for Popponesset Bay.
- Helped prepare the technical report on the MEP study for Rushy Marsh.
- In spring 2007, the state Department of Environmental Protection (DEP) released the MEP technical report on the Centerville River. In September 2007, Commission staff provided technical comments to DEP on the proposed draft nitrogen-loading limits (known as TMDLs, Total Maximum Daily Loads).
- Developed Massachusetts Estuaries Project (MEP) watershed, land use, and nitrogen loading information for Lewis Bay, Halls Creek, and Snows Creek. In June 2007, the MEP technical report was submitted to the state DEP. In October, Commission staff made a presentation of the pre-public draft to town staff.
- Performed remedial action and developed an immediate response plan for groundwater clean-up at the Barnstable County Fire Training Academy. Submitted a report to the state DEP in August 2007. The clean-up requires ongoing monitoring, operation, and maintenance of groundwater treatment systems. In November 2007, Commission staff replaced a recovery well for the clean-up system.
- Performed a water-quality assessment of Lake Wequaquet. Collected the sixth round of monthly samples in September 2007 and the final round of monthly samples in early November, and then began the data analysis phase. Coordinated the work with the Lake Wequaquet Protective Association and the Town of Barnstable.
- Performed a data and monitoring review of all available pond data for the town, and submitted a final report ("Barnstable Ponds: Current Status, Available Data, and Recommendations for Future Activities") to the town in June 2008.
- Continued to coordinate the Cape-wide Pond and Lake Stewardship Project; as part of the annual water-quality monitoring program, samples were collected and analyzed from 21 ponds and lakes in Barnstable.
- Assisted the Hyannis Water Division and Barnstable County on a Memorandum of Understanding to install back-up gas-fired generators at two major public water supply wells.

Regulatory Reviews

• Approved DRIs for (1) the Barnstable Wastewater Facilities Plan (09/20/07), the town's long-term strategy for wastewater treatment and disposal in the eastern part

of town (and more); (2) the Circuit City Redevelopment Project (02/07/08) on Route 132, for the demolition of two buildings (a restaurant and an insurance office) and the construction of a new retail facility; and (3) the Atlantis Development/Stop & Shop (06/12/08) on Route 132, for the demolition of five existing structures (105,000 sq.ft. total) and the construction of a new 69,770-sq.ft. supermarket.

- Approved a DRI Exemption for The Cape Codder Resort (01/10/08) on Route 132, for an expansion of the hotel facility with spa, swimming pool, and more.
- Approved Hardship Exemptions for (1) the Cape Flight Instruction/Nantucket Shuttle Hangar (01/24/08) at the Barnstable Municipal Airport, for an already-built metal airplane hangar for storage and maintenance of the Nantucket Shuttle fleet; and (2) the Rose Motel Redevelopment/Lakeside Commons (03/20/08) on Route 132, for the demolition of the existing Rose Motel and the construction of a new office and drive-thru bank in one building.

- Continued to coordinate the Cape-wide Pond and Lake Stewardship Project; as part of the annual water-quality monitoring program, samples were collected and analyzed from four ponds in Bourne.
- Assisted the Bourne Wastewater Committee on potential wastewater-facility siting issues.
- Participated in the Massachusetts Military Reservation-related Impact Area Groundwater Program Review Team and the Plume Clean-up Team.

BREWSTER

Affordable Housing

- Provided more than \$16,000 in HOME down-payment funds to two households.
- Provided one Soft Second Loan Program mortgage to a first-time homebuyer.
- Continued to serve as the Chapter 40B project administrator for the Slough Road affordable housing development.

Geographic Information System

- Provided GIS assistance about open space for the town and the Brewster Land Trust through The Compact of Cape Cod Conservation Trusts.
- Prepared a map of water resources for the Brewster Planning Board.
- Began an update of Brewster zoning data. (Once the zoning data update is complete, the staff will also create an interactive map with natural resources and zoning features.)
- Prepared a map for the town's Agricultural Commission that inventories lands in Brewster that are reserved for agricultural uses.
- Created several maps related to the proposed Brewster Water Protection District of Critical Planning Concern (DCPC).

Planning and Community Development

- Supported the town's nomination of the Brewster Water Protection District of Critical Planning Concern (DCPC). The Barnstable County Assembly of Delegates designated the district on July 2, 2008.
- Worked with graduate students from the Boston University Historic Preservation Program to create an inventory of cultural landscapes.

• Worked with Brewster town staff and officials to develop the town's portion of the Regional Land Use Vision Map, which, among other uses, will help define the Commission's regulatory thresholds and development review standards. The Brewster Planning Board has endorsed the town's portion of the map.

Transportation

- Began work on an update to the 1995 Route 6A Scenic Byways "Corridor Management Plan." Work by year end included the identification of data and analysis needs and the creation of an online questionnaire to enhance public participation.
- Continued to coordinate the Flex Working Group to monitor, update, and maintain the Flex transit service.
- Continued to assist the development of a satellite maintenance center for Cape Cod Regional Transit Authority services and town vehicles. In April 2008, began a study with the Cape Cod National Seashore and the Volpe Center.
- Worked with Bridgewater State College to develop a vehicle-tracking system for transit and other applications and tested it with the Brewster Fire Department.
- Conducted traffic counts at 12 Brewster locations (intersections and road segments) in the summer of 2007, as part of the Commission's annual Cape-wide traffic-counting program.

Water Resources

- Continued to provide assistance with the implementation of Pleasant Bay's Total Maximum Daily Loads (TMDLs) for nitrogen, in coordination with the Pleasant Bay Alliance. In September 2007, the state Department of Environmental Protection (DEP) launched a pilot implementation project for the Pleasant Bay estuary; the Commission staff helped develop scenario runs with the MEP technical team and developed watershed nitrogen loads and a map corresponding to TMDL subwatershed groupings.
- Developed Massachusetts Estuaries Project (MEP) watershed, land use, and nitrogen loading information for Namskaket Marsh. The technical report was submitted to the state DEP in June 2007. A presentation of pre-public draft was made to town staff in October. Current Commission work includes developing subwatershed nitrogen loads by town for Namskaket Marsh in anticipation of discussions about Total Maximum Daily Loads (TMDLs).
- Reviewed volunteer-collected water quality data for selected ponds and prepared a report for the town.
- Continued to coordinate the Cape-wide Pond and Lake Stewardship Project; as part of the annual water-quality monitoring program, samples were collected and analyzed from 25 ponds in Brewster.
- Continued to provide support for the management of Long Pond's water quality, including helping to secure the Conservation Commission's approval of the application of alum and reviewing local regulations to better protect pond water quality. The alum application took place in Fall 2007.
- Provided technical assistance to the town as it prepared the nomination form for the Brewster Water Protection District of Critical Planning Concern (DCPC); assistance with the town's development of DCPC implementing regulations is ongoing.

Regulatory Reviews

• At year end, one Development of Regional Impact review was still in process: the Nickerson Family Property, a proposed 15-acre horse farm at a site within a contributing area to the Orleans public water supply.

CHATHAM

Affordable Housing

- Provided more than \$16,000 in HOME down-payment funds to two households.
- Reviewed and provided technical comments on an inclusionary-housing zoning bylaw.

Planning and Community Development

• Worked with Chatham town staff and the planning board to develop the town's portion of the Regional Land Use Vision Map, which, among other uses, will help define the Commission's regulatory thresholds and development review standards. Next steps will involve further discussions and revisions with town staff and officials, followed by a public forum.

• Worked with Wellfleet town staff and officials to develop the town's portion of the Regional Land Use Vision Map, which, among other uses, will help define the Commission's regulatory thresholds and development review standards. Also held a public forum to consider the proposed map.

Transportation

- Continued to coordinate the Flex Working Group to monitor, update, and maintain the Flex transit service.
- Continued to assist the development of a satellite maintenance center for Cape Cod Regional Transit Authority services and town vehicles. In April 2008, began a study with the Cape Cod National Seashore and the Volpe Center.
- Assisted in the planning for relocation of a Flex transit bus stop to Marconi Road, and in the design of a Flex transit bus facility.
- Conducted traffic counts at five Wellfleet locations (intersections and road segments) in the summer of 2007, as part of the Commission's annual Cape-wide traffic-counting program.

Water Resources

• Continued to coordinate the Cape-wide Pond and Lake Stewardship Project; as part of the annual water-quality monitoring program, samples were collected and analyzed from three ponds in Wellfleet.

YARMOUTH

Affordable Housing

- Committed \$130,000 in HOME funds to the Yarmouth Home Ownership Project of Housing Assistance Corporation.
- Provided three Soft Second Loan Program mortgages to first-time homebuyers.

Planning and Community Development

- Approved the Yarmouth Growth Incentive Zone, a 5.2-mile corridor along Route 28, in July 2007. The Barnstable County Assembly of Delegates approved the related DRI threshold changes for hotel/motel properties within the zone in October 2007. The threshold changes allow properties to be renovated or converted to residential units or mixed-use developments with less regulatory involvement by the Cape Cod Commission.
- Provided historical information and an assessment of significance for the 1750 House.
- Provided \$48,066 in Development of Regional Impact (DRI) mitigation funds toward the Route 28 Village Center study.
- Worked with Yarmouth town staff and the planning board to develop the town's portion of the Regional Land Use Vision Map, which, among other uses, will help define the Commission's regulatory thresholds and development review standards. Next steps will involve further discussions and revisions with town staff and officials, followed by a public forum.

Transportation

- Provided support for MassHighway's "Hyannis Access Study," including staffing the task force subcommittees for roadways, transit, and bicycle/pedestrian issues.
- Began work on an update to the 1995 Route 6A Scenic Byways "Corridor Management Plan." Work by year end included the identification of data and analysis needs and the creation of an online questionnaire to enhance public participation.
- Provided \$28,439 in Development of Regional Impact (DRI) mitigation funds toward a feasibility study of the proposed westerly extension of the Cape Cod Rail Trail.
- Conducted traffic counts at 16 Yarmouth locations (intersections and road segments) in the summer of 2007, as part of the Commission's annual Cape-wide traffic-counting program.
- Coordinated the collection of traffic and bicycle/pedestrian data, at the town's request.

Water Resources

- Continued to develop the Massachusetts Estuaries Project (MEP) watershed, land use, and nitrogen loading model for the Parkers River estuary system.
- Developed Massachusetts Estuaries Project (MEP) watershed, land use, and nitrogen loading information for Lewis Bay, Halls Creek, and Snows Creek. In June 2007, the MEP technical report was submitted to the state Department of Environmental Protection (DEP). In October, Commission staff made a presentation of the pre-public draft to town staff.
- Continued to coordinate the Cape-wide Pond and Lake Stewardship Project; as part of the annual water-quality monitoring program, samples were collected and analyzed from five ponds in Yarmouth.

Regulatory Reviews


- Approved a DRI for the KeySpan Sagamore Line Reinforcement Project Middle Segment, Phase 2 (01/24/08), for the continued construction of a new high-pressure gas-distribution pipeline; this segment is 13,000 feet in length through Yarmouth, Dennis, and Harwich.
- Denied on procedural grounds a DRI for the Cape Wind Energy Project (10/18/07) in Nantucket Sound, with rights-of-way in Yarmouth and Barnstable, for a submarine and upland cable system to transmit electricity from a proposed offshore wind park.
- In process is a review of the proposed Parker's River Marine Park.



Development of Regional Impact (DRI) Mitigation Funds

To be approved, a project undergoing Cape Cod Commission regulatory review may be required to address problems resulting from the development, such as making traffic improvements or providing affordable housing in a new residential development. When it is not practical to correct a problem directly, the developer may be required to contribute a fair share of funds to solve the problem rather than undertake the actual work. Funds collected for these purposes are held in a special revenue account by the Barnstable County Treasurer and are tracked by project. Interest accrues on this account. The Cape Cod Commission works with town officials to determine the best use of these funds. Typically, after local officials have identified a project for which mitigation funds can be utilized, a request is submitted to the Commission and a Memorandum of Agreement is executed with the town.
