Extension Agreement- DRI Public Hearing Period


Re: Development of Regional Impact
Bourne ISWMF Phases 7, 8 & 9 (Commission File No. 20064)

1. The above referenced matter ('Project') required the preparation of an environmental impact report (EIR) under the provisions of sections sixty-one to sixty-two I, inclusive, of chapter thirty of the General Laws, the Massachusetts Environmental Policy Act (MEPA) and thus is subject to mandatory Development of Regional Impact (DRI) review by the Cape Cod Commission (Commission) pursuant to Section 12(i) of the Cape Cod Commission Act;
2. The Secretary of the Massachusetts Executive Office of Energy and Environmental Affairs issued a Certificate on the Project's Single Supplemental Environmental Impact Report (SSEIR) December 30, 2020, determining that the Project adequately and properly complies with MEPA.
3. The Cape Cod Commission opened the Development of Regional Impact (DRI) public hearing period on the Project by hearing officer February 12, 2021.
4. Pursuant to Section 6(c)(vi) of the Enabling Regulations Governing Developments of Regional Impact/ Chapter A of the Code of Cape Cod Commission Regulations of General Application (as amended), the Applicant Town of Bourne and the Cape Cod Commission hereby mutually agree to extend the DRI public hearing period on the above-referenced matter to November 1, 2021, which further extension will allow adequate time for the Town to prepare and Commission staff and subcommittee to review a DRI application, particularly as the Town looks to coordinate and pursue its state permitting for the Project.
