

Complete Streets Prioritization Plan



- State Highways (Route 28, Route 28A, etc.) are not eligible for MassDOT Complete Streets Funding Program, but can be included in the plan
- Plan can be based off the Town's CIP, LCP, ADA plan, Bike Plan, RSAs, etc.
- Plan will include a public outreach element
- Plan will identify project details: readiness, project cost, benefits
- Plan will prioritize projects based on a set of evaluation criteria
- Plan should be regularly updated

Complete Streets Prioritization Plan



 As part of the Complete Streets Prioritization Plan, the municipality (Town of Bourne) chooses the projects they would like to advance for design and funding while also controlling all the design decisions for the project

Bourne Rail Trail

Part of 'Vision 88'

- Phase 1 funded for \$2,150,400 in 2024
- Phase 1 is a half-mile path from the Canal Bike Path south to Monument Neck Road
- Phase 1 is currently at 25% design
- Phase 2 is a 2-mile path from the terminus of Phase I to Monk's Park/Valley Bars Road
- Phase 2 is currently unprogrammed at a cost of \$7,610,000
- Phase 4B is moving forward with the section of path in N. Falmouth to connect Bourne to the Shining Sea Bikeway (unprogrammed at \$6,375,000)
